Application Submission Instructions

1. Complete the application form and prepare a copy of the PwD certification. If you are visiting attractions where multiple accompanying caregivers are permitted, the primary caregiver's full name must be registered in the application.
2. Submit your application via **Sentosa Contact Us webform** at www.sentosa.com.sg/contact-us. Select "Sentosa Cares Benefits Programme" under the Category dropdown option and **attach the completed application form and a copy of the PwD certification**.
3. Applications must be submitted **at least 7 working days before your intended visit**. Upon successful verification, a confirmation email will be sent to the email address provided in this application form within 5 working days from the date of application.
4. The **verified PwD and accompanying caregiver(s) must be present together**, along with a copy of **the confirmation letter and a valid photo ID** (e.g. Identity Card, Driver License) at each attraction to enjoy the programme benefits. Those unable to present the confirmation letter, valid photo ID for verification, or whose name on the confirmation email does not match the ID presented will be requested to purchase full-priced tickets.
5. For attractions requiring the purchase of caregiver discounted ticket, the ticket can be purchased directly at the participating attraction or any of [Sentosa Guest Services/ Ticketing Counters](#) **on the day of visit**.
6. Please note that the number of accompanying caregivers allowed per PwD and the ticket discounts may vary by attraction. Applicants are advised to carefully read the list of participating attractions and their respective offers as well as terms and conditions before submitting the form.
