#### ATTACHMENT A – EVALUATION CRITERIA

Subject to compliance with **Clause 12 of the Instructions to Tenderers**, Tender Offers shall be evaluated based on the following criteria:

#### **Critical Criteria**

Non-compliance with any of the following critical criteria will preclude the Tender Offer from further evaluation by the SGC.

(i) Registration with Government Registration Authority

The Tenderer shall be registered with Building Construction Authority (BCA) under the "CR06 - Interior Decoration & Finishing Works" work head with financial category of L1 (\$0.65 million) and above.

#### (ii) Debarment Status

The Tenderer shall not be suspended or debarred by the Standing Committee On Debarment, c/o Ministry of Finance, from participating in public-sector projects.

### (iii) bizSAFE Certification

The Tenderer shall have attained bizSAFE Level 3 and above.

(iv) Full compliance with components of the Invitation to Tender

The Tender Offer shall comply fully with the Form of Tender, General Information and the Conditions of Contract.

#### **Other Criteria**

The following criteria are listed in order of importance from highest to lowest, i.e. criterion (v) being the most important and criterion (viii) being the least important.

- (v) Price competitiveness of the Tender Offer;
- (vi) Conformance with the Requirement Specifications;
- (vii) Tenderer's ability and expertise to undertake the Contract

Tenderer shall submit the following as part of the Tender Offer:

a. Track Records – The Tenderer shall demonstrate the experience and track record in implementing projects of similar scale to this tender (projects more than \$200K), with at least three (3) project references in the last five (5) years in Singapore.
