- 12.3 The Tenderer's Tender Offer may include qualifications or variations to any provision of this Invitation to Tender or may be an offer which does not fully comply with the Requirement Specifications.
- 12.4 Notwithstanding Clause 12.3, the Tenderer <u>cannot vary</u> the following clauses in this Invitation to Tender:
 - a. All clauses in the Form of Tender; and
 - b. All clauses in the General Information.
- 12.5 Each alternative tender shall be clearly marked and identified as Alternative Tender Offer on a photocopy of the Form of Tender and all pricing documents. The Form of Tender and all pricing documents for the Alternative Tender Offer shall be submitted together with the Form of Tender containing the Base Tender Offer. A separate Form of Tender and all pricing documents are required for each Alternative Tender Offer.

ATTACHMENT A – EVALUATION CRITERIA

Subject to compliance with **Clause 12 of the Instructions to Tenderers**, Tender Offers shall be evaluated based on the following criteria:

Critical Criteria

Non-compliance with any of the following critical criteria will preclude the Tender Offer from further evaluation by the SGC.

(i) Eligibility

Tenderers must have relevant proven track records and <u>minimum of five years</u> <u>experience</u> in the supply and maintenance of golf course equipment and machinery in Singapore;

<u>OR</u>

Tenderers must have relevant proven track records and <u>minimum of five years</u> <u>experience</u> in the production, supply and maintenance of golf course equipment Worldwide.

Other Criteria

The following criteria are listed in order of importance from highest to lowest, i.e. **criterion** (ii) being the most important and criterion (vii) being the least important.

(ii) Full compliance with components of the Invitation to Tender

The Tender Offer shall comply fully with the Form of Tender, the General Information and the Conditions of Contract.

(iii) Substantial Conformance with the Requirement Specifications

Tenderers are to submit the following as part of the Tender Offer:

- a. Brochures / catalogues to demonstrate that the proposed Golf Equipment and Machinery meet the Requirement Specifications; and
- b. Schedule of Technical Data in the format provided in the Invitation to Tender documents.

(iv) Tenderer's Financial Standing

Tenderers shall submit relevant financial information, including financial information of their parent company and manufacturer, to demonstrate the sound financial standing to undertake the Fleet Management Partnership Programme.

The financial information shall include the audited financial statements with accompanying Notes to Accounts and Auditor's Report for the latest 3 financial years (un-audited or draft version shall be submitted if the audited statements are not available. This shall be signed off by at least a Director of the Company). If the latest financial year had ended more than 3 months from the Closing Date and Time of this Invitation to Tender, Tenderers shall submit the Management Accounts (Balance Sheet, Income Statement and Cashflow Statement) signed off by at least a Director of the company, properly classified, for the interim period from the beginning of the current financial year to the latest month available.

(v) Price competitiveness of the Tender Offer;

The price competitiveness of the Tender Offer shall be determined by the holistic review of the following areas:

- 1a. Tender Offer for Base Tender 1: Purchase (including trade-in of the (new) purchased equipment to be refreshed within the Contract Period); and/or
- 1b. Tender Offer for Base Tender 2: Leasing
- 2. Total Trade-in Price for the existing (old) SGC equipment
- 3. Tender Offer for Option to Purchase/ Lease additional equipment
- 4. Price competitiveness of the Spare Parts
- 5. Equipment Lifecycle Costing
- 6. Tender Offer for Option for Maintenance & Servicing
- 7. Partnership programme and marketing sponsorship (where applicable)

(vi) Value-added services/ inputs as part of the Partnership

Tenderer should demonstrate the ability to provide relevant value-added services/inputs for the long term partnership with SGC including:

- a. <u>Spare Parts</u> Tenderers shall submit their complete international spare parts listing as of the Closing Date.
- b. <u>Refreshed Products</u> Tenderers shall submit a proposal for the supply and delivery of refreshed products (e.g. lithium battery equipment, robotics, etc.) to SGC for replacement of original products offered in the Tender, as and when released during the Contract Period.
- c. <u>Maintenance and Servicing Programme outside of Warranty Term</u> Tenderers shall submit a proposal for the maintenance and servicing programme including the proposed turnaround time for equipment and machinery to be repaired, replacement equipment and machinery, spare parts management, on-site workshop/ inventory management system, etc. Tenderers are requested to price for comprehensive and/or non-comprehensive maintenance and servicing of the equipment and machinery.

- d. Research & Development (R&D) and Sustainability Programme Tenderers shall provide statements of commitment on year on year research and development and their commitment to sustainability, including the commitment to develop new equipment and machinery that reduces carbon use. Tenderer shall elaborate on sustainability advantages including carbon reducing capabilities of their proposed equipment and machinery, where applicable.
- e. <u>Productivity</u> Tenderers shall elaborate on the productivity advantages of their proposed equipment, where applicable.
- f. Others Partnership and Marketing Programme
 - Use of SGC as a Centre of Excellence / Test-bed / Beta facility
 - Major tournament support to SGC
 - Training opportunities for SGC staff
 - Sponsorship, marketing, media coverage, etc

(vii) Tenderer's ability and expertise to undertake the Contract:

Tenderer shall submit the following as part of the Tender Offer:

- a. Relevant Track Records The Tenderer shall demonstrate the experience and track record in implementing projects of similar scale and nature to this tender. The Tenderer shall submit the relevant track records with details of the project(s) title, commencement date, completion date, project value and the working relationship with the manufacturer.
- b. Resource and Expertise The Tenderer shall have an established local team in Singapore to undertake the Fleet Management Partnership Programme. The Tenderer shall submit the organisation and structure for the local team, the number of headcount, Curriculum Vitaes (CV) of key personnel (including service engineers and service technicians).
- c. <u>Maintenance Support Team</u> Tenderer shall submit the proposed maintenance support team structure for this Contract, including target headcount and minimal qualifications (CV of personnel undertaking the key assigned roles) and years of experience of the personnel to carry out the maintenance and servicing programme.
